Dear Ms. Kostbar:

You ask whether certain information is subject to required public disclosure under the Public Information Act (the "Act"), chapter 552 of the Government Code. Your request was assigned ID# 551129 (HCAD Ref. No. 14-4164).

The Harris County Appraisal District (the "district") received a request for a list of all vehicles associated with a specified account. You state the district will release some information to the requestor. You claim the submitted vehicle identification and license plate numbers are excepted from disclosure under section 552.130 of the Government Code.¹ We have considered the exception you claim and reviewed the submitted information.

Section 552.130 of the Government Code excepts from disclosure information that relates to a motor vehicle title or registration issued by an agency of this state or another state or country. Gov't Code § 552.130(a)(2). Thus, the submitted vehicle identification and license

¹We note, and you acknowledge, the district did not comply with the requirements of section 552.301 of Government Code. See Gov't Code § 552.301(b), (e). Nonetheless, section 552.130 of the Government Code is a mandatory exception that can provide a compelling reason to overcome the presumption of openness caused by failure to comply with section 552.301. See *id.* §§ 552.007, .302. Thus, we will consider the district's claim.

plate numbers are generally excepted from public disclosure under section 552.130 of the Government Code.

We understand you to assert the requestor may have a right of access to the information at issue under section 730.007(a) of the Transportation Code. *See id.* § 552.130(b); Transp. Code § 730.007(a) (personal information obtained in connection with motor vehicle record may be disclosed under certain circumstances). We note that chapter 730 is applicable to an “agency . . . that compiles or maintains motor vehicle records.” Transp. Code § 730.003(1). The district is not an agency as defined by section 730.003(1). Therefore, chapter 730 does not apply to the district. Accordingly, we conclude the requestor does not have a right of access to this information pursuant to chapter 730 of the Transportation Code.

We note, however, section 552.130 protects personal privacy. In the event the requestor is the authorized representative of the property owner at issue, she has a special right of access to the motor vehicle information of the owner she represents pursuant to section 552.023 of the Government Code. *See* Gov’t Code § 552.023(a) (person or person’s authorized representative has special right of access, beyond right of general public, to information held by governmental body that relates to person and is protected from public disclosure by laws intended to protect person’s privacy interests); Open Records Decision No. 481 at 4 (1987). We note section 552.229(a) of the Government Code provides consent for release of information available under section 552.023 must be in writing and signed by the person or the person’s authorized representative. Gov’t Code § 552.229(a). Thus, under section 552.023, with proper authorization from the property owner at issue, the requestor in this case would have a right of access to information that would ordinarily be withheld under section 552.130 to protect the property owner’s privacy interests. In that event, the district may not withhold any of the information at issue under section 552.130 of the Government Code.

In summary, the district must generally withhold the submitted vehicle identification and license plate numbers under section 552.130 of the Government Code. However, if the requestor provides proper authorization from the property owner, the district must release the vehicle identification and license plate numbers to this requestor pursuant to section 552.023 of the Government Code. In either instance, the district must release the remaining information.

This letter ruling is limited to the particular information at issue in this request and limited to the facts as presented to us; therefore, this ruling must not be relied upon as a previous determination regarding any other information or any other circumstances.
