Dear Mr. Calderon:

You ask whether certain information is subject to required public disclosure under the Public Information Act (the "Act"), chapter 552 of the Government Code. Your request was assigned ID# 569170.

Southwest Key Programs, Inc. ("SWK") received a request for seven categories of information related to the Nueces County Juvenile Justice Alternative Education Program (the "Nueces JJAEP") and Calallen Independent School District ("Calallen ISD"), including a specified memorandum of understanding. Although you take no position as to whether the submitted information is excepted under the Act, you state release of the submitted information may implicate the proprietary interests of Calallen ISD, Nueces JJAEP, Nueces County Juvenile Board (the "board"), Aransas Pass Independent School District, Corpus Christi Independent School District, Flour Bluff Independent School District, Robstown Independent School District, Tuloso-Midway Independent School District, and West Oso Independent School District (collectively, the "districts"). Accordingly, you state, and provide documentation showing, you notified Calallen ISD, Nueces JJAEP, the board, and the districts of the request for information and of their right to submit arguments to this office as to why the submitted information should not be released. *See* Gov't Code § 552.304 (interested party may submit comments stating why information should or should not be released). We have reviewed the submitted information.

As of the date of this letter, we have not received comments from Calallen ISD, Nueces JJAEP, the board, or the districts explaining why the submitted information should not be

released. Therefore, we have no basis to conclude Calallen ISD, Nueces JJAEP, the board, or the districts have a protected interest in the submitted information. Accordingly, SWK may not withhold the submitted information on the basis of any interest Calallen ISD, Nueces JJAEP, the board, or the districts may have in the information. As no exceptions to disclosure have been raised, SWK must release the submitted information.

This letter ruling is limited to the particular information at issue in this request and limited to the facts as presented to us; therefore, this ruling must not be relied upon as a previous determination regarding any other information or any other circumstances.

This ruling triggers important deadlines regarding the rights and responsibilities of the governmental body and of the requestor.
