Dear Mr. Fletcher:

You ask whether certain information is subject to required public disclosure under the Public Information Act (the "Act"), chapter 552 of the Government Code. Your request was assigned ID# 662965 (City Request No. 2017-49).

The City of Eagle Pass (the "city"), which you represent, received a request for information contained in three specified server locations. You state some information is not subject to the Act. In the alternative, you claim the submitted information is excepted from disclosure under section 552.139 of the Government Code. We have your arguments and reviewed the submitted representative samples of information.¹

Initially, you argue some of the submitted information is not "public information" subject to disclosure under the Act. Section 552.002(a) of the Government Code defines "public information" as information that is written, produced, collected, assembled, or maintained under a law or ordinance or in connection with the transaction of official business:

(1) by a governmental body;

(2) for a governmental body and the governmental body:

(A) owns the information;

(B) has a right of access to the information; or

(C) spends or contributes public money for the purpose of writing, producing, collecting, assembling, or maintaining the information; or

(3) by an individual officer or employee of a governmental body in the officer's or employee's official capacity and the information pertains to official business of the governmental body.

Gov't Code § 552.002(a). In Open Records Decision No. 581 (1990), this office determined certain computer information, such as source codes, documentation information, and other computer programming, that has no significance other than its use as a tool for the maintenance, manipulation, or protection of public property is not the kind of information made public under section 552.021 of the Government Code. You argue some of the submitted information consists of source code and documentation information. Further, you argue the information is used solely for the purpose of maintenance, manipulation, or protection of public property. Based on your representations and our review, we find some of the submitted information is not public information for purposes of the Act, and the city is not required to release it in response to this request. However, the remaining information at issue has significance other than its use as a tool for the purpose of maintenance, manipulation, or protection of public property. Accordingly, we conclude the remaining information is public information as defined by section 552.002 and is subject to disclosure under the Act. Thus, we will address your argument under section 552.139.

Section 552.139 of the Government Code provides, in relevant part:

(a) Information is excepted from [required public disclosure] if it is information that relates to computer network security, to restricted information under Section 2059.055 [of the Government Code], or to the design, operation, or defense of a computer network.

Id. § 552.139(a). You state the remaining information relates to the design and defense of a computer network. You explain the remaining information contains information pertaining to the password policy and backup procedures of the city, information pertaining to city servers, and information pertaining to software and hardware used by the city. You also state some of the submitted information reveals proposed upgrades to city servers or design of proposed servers. Based on your arguments and our review of the information, we find some of the remaining information relates to computer network security, and the design, operation, or defense of the city's computer network. However, we find you failed to demonstrate the

remaining information, including information pertaining to proposed servers and proposed upgrades, relates to the specifics of the city's computer network security, or to the design, operation, or defense of the city's computer network as contemplated in section 552.139(a). Accordingly, with the exception of the information we marked for release, the city must withhold the remaining information under section 552.139 of the Government Code.

In summary, some of the submitted information is not public information for purposes of the Act, and the city is not required to release it in response to this request. With the exception of the information we marked for release, the city must withhold the remaining information under section 552.139 of the Government Code. The information marked for release must be released.

This letter ruling is limited to the particular information at issue in this request and limited to the facts as presented to us; therefore, this ruling must not be relied upon as a previous determination regarding any other information or any other circumstances.

This ruling triggers important deadlines regarding the rights and responsibilities of the governmental body and of the requestor.
