Dear Mr. Paris:

You ask whether certain information is subject to required public disclosure under the Public Information Act (the "Act"), chapter 552 of the Government Code. Your request was assigned ID# 815924 (W094952).

The City of Fort Worth (the "city") received a request for information pertaining to a specified incident report number. We understand the city has released some of the requested information. You claim the submitted information is excepted from disclosure under section 552.101 of the Government Code. Additionally, you state, and provide documentation showing, the city notified the next of kin of a deceased individual of the right to submit comments to this office explaining why the information at issue should not be released. *See* Gov't Code § 552.304 (interested party may submit comments stating why information should or should not be released). We have considered the exception you claim and reviewed the submitted representative sample of information.¹

We note the submitted information is subject to section 552.1085 of the Government Code.² Section 552.1085(c) of the Government Code provides the following:


(c) A sensitive crime scene image in the custody of a governmental body is confidential and excepted from the requirements of Section 552.021 and a governmental body may not permit a person to view or copy the image except as provided by this section. This section applies to any sensitive crime scene image regardless of the date that the image was taken or recorded.

Gov't Code § 552.1085(c). For purposes of section 552.1085, "sensitive crime scene image" means "a photograph or video recording taken at a crime scene, contained in or part of a closed criminal case, that depicts a deceased person in a state of dismemberment, decapitation, or similar mutilation or that depicts the deceased person's genitalia." *See id.* § 552.1085(a)(6). We note the submitted photographs consist of sensitive crime scene images that were taken at a crime scene as part of a criminal case the city represents is closed. The request for information reveals the requestor does not represent the deceased person's next of kin. *See id.* § 552.1085(d)(1). Based on these representations, we find the submitted photographs consist of sensitive crime scene images for the purposes of section 552.1085 of the Government Code. Therefore, the city must withhold the submitted information under section 552.1085 of the Government Code.³

This letter ruling is limited to the particular information at issue in this request and limited to the facts as presented to us; therefore, this ruling must not be relied upon as a previous determination regarding any other information or any other circumstances.

This ruling triggers important deadlines regarding the rights and responsibilities of the governmental body and of the requestor.
