Dear Ms. Godbey:

You ask whether certain information is subject to required public disclosure under the Public Information Act (the "Act"), chapter 552 of the Government Code. Your request was assigned ID# 826843 (TRS Reference# 20-2).

The Teacher Retirement System of Texas (the "system") received a request for specified correspondence between the system and the Office of Attorney General. You claim the submitted information is excepted from disclosure under sections 552.101, 552.107, and 552.143 of the Government Code.<sup>1</sup> Additionally, you state release of this information may implicate the proprietary interests of interested third parties. Accordingly, you state, and provide documentation showing, you notified these third parties of the request for information and of their right to submit arguments to this office as to why the information at issue should not be released. *See* Gov't Code § 552.305(d); *see also* Open Records Decision No. 542 (1990) (statutory predecessor to section 552.305 permits governmental

body to rely on interested third party to raise and explain applicability of exception in the Act in certain circumstances). We have received comments from Academy, Ltd. d/b/a Academy Sports and Outdoors (“Academy”). We have also received and considered comments from the requestor. *See* Gov’t Code § 552.304 (permitting interested third party to submit to attorney general reasons why requested information should or should not be released). We have considered the submitted arguments and reviewed the submitted representative sample of information.<sup>2</sup>

Section 552.143 of the Government Code provides, in part, the following:

(a) All information prepared or provided by a private investment fund and held by a governmental body that is not listed in Section 552.0225(b) is confidential and excepted from the requirements of Section 552.021.

(b) Unless the information has been publicly released, pre-investment and post-investment diligence information, including reviews and analyses, prepared or maintained by a governmental body or a private investment fund is confidential and excepted from the requirements of Section 552.021, except to the extent it is subject to disclosure under Subsection (c).

*Id.* § 552.143(a)-(b). The system states the information at issue consists of post-investment due diligence information prepared for and maintained by the system. You inform us this information has not been publicly released and is not subject to disclosure pursuant to section 552.143(c). Based on these representations and our review, we find the system has demonstrated the applicability of section 552.143(b) to the information at issue. Thus, the system must withhold the submitted information under section 552.143(b) of the Government Code.<sup>3</sup>

This letter ruling is limited to the particular information at issue in this request and limited to the facts as presented to us; therefore, this ruling must not be relied upon as a previous determination regarding any other information or any other circumstances.

This ruling triggers important deadlines regarding the rights and responsibilities of the governmental body and of the requestor.
