The Office of the Attorney General has received your request for a ruling and assigned your request ID# 930547.

After reviewing your arguments and the submitted information, we have determined your request does not present a novel or complex issue. Thus, we are addressing your claims in a memorandum opinion. You claim the submitted information must be withheld from the requestor pursuant to section 552.1331 of the Government Code.<sup>1</sup> Upon review of your arguments and the submitted information, we conclude you must withhold the submitted information under section 552.1331 of the Government Code.

<sup>1</sup> We note, and you acknowledge, the city failed to comply with the procedural requirements of section 552.301 of the Government Code in requesting a decision from this office. *See* Gov't Code § 552.301(b). Nonetheless, section 552.1331 of the Government Code can provide a compelling reason to overcome the presumption of openness caused by a failure to comply with section 552.301. *See id.* §§ 552.007, .302, .352. Thus, we will consider the applicability of this exception to the submitted information, notwithstanding the city's violation of section 552.301 in requesting this decision.
