Dear Mr. Kadas:

You ask whether certain information is subject to required public disclosure under the Public Information Act (the "Act"), chapter 552 of the Government Code. Your request was assigned ID# 955421 (Ref. No. R000461-040422).

The Texas Parks and Wildlife Department (the "department") received a request for information pertaining to a specified boating accident. You claim the submitted information is subject to a previous determination. In the alternative, you claim the submitted information is excepted from disclosure under section 552.101 of the Government Code. We have considered the submitted arguments and reviewed the submitted information.

In Open Records Letter No. 2002-5382 (2002), this office issued a previous determination to the department authorizing it to withhold boating accident reports as defined in section 31.105 of the Parks and Wildlife Code and attachments under section 552.101 of the Government Code in conjunction with section 31.105 without requesting a decision from this office. *See* Gov't Code § 552.301(a); Open Records Decision No. 673 (2001) (listing elements of second type of previous determination under section 552.301(a) of the Government Code). The submitted information consists of a boating accident report as defined in section 31.105. Thus, the department may continue to rely on Open Records Letter No. 2002-5382 as a previous determination and must withhold the submitted information in accordance with that ruling.<sup>1</sup>

<sup>1</sup> Although, the Texas legislature amended section 31.105 in 2011 to increase the monetary amount specified in subsection (a), we determine you may still rely on Open Records Letter No. 2002-5382 as a previous determination. *See* Act of May 18, 2011, 82nd Leg., R.S., H.B. 555, § 1 (codified as section 31.105(a) of the Government Code).

This letter ruling is limited to the particular information at issue in this request and limited to the facts as presented to us; therefore, this ruling must not be relied upon as a previous determination regarding any other information or any other circumstances.
